Purpose:

The aim of the KiwiRail Graduate Programme "the Programme" is to attract and grow young and diverse talent for future operational, technical and leadership roles across KiwiRail.

The Programme will provide the Graduate with a supportive environment, rotation across a number of different areas of the business, on-the-job training, mentoring and a strong emphasis on learning and development.

The Programme requires the Graduate to be flexible with their hours of work and the location they are based from. While the ordinary hours of work will be Monday to Friday, there will be an expectation of some weekend work as our operation is 24/7. In addition while the Graduate will have a main location where they are based, there will be a requirement to travel and work in other locations to gain exposure to different areas of the business.

The Graduate is responsible for applying their academic learning to practical workplace experience in the business area aligned to their academic background.

During the course the Programme, the Graduate will:

- Gain a thorough understanding of the Company's business drivers, strategies, processes and systems.
- Undertake technical and professional development activities to complement their on the job training across different work areas.
- Work collaboratively in a team and across different teams and work environments.
- Undertake project work and participate in project teams to achieve work outcomes for the business.
- Undertake research, analysis and reporting on the business or relevant issues that can be applied in a practical setting.
- Understand and comply with all KiwiRail's Zero Harm requirements.

At the end of the Programme the Graduate will have a solid understanding of KiwiRail, the different business areas and how the business areas work together to provide an integrated logistics solution for New Zealand.

The Graduate will also have solid practical experience in their area of study that they will be able to apply to future roles within KiwiRail.
